FOUNDING AFFIDAVIT

I, the undersigned,

CASPER HENDRIK DU PLESSIS

do hereby make oath and state as follows: -

 I am a major male, duly admitted attorney of the High Court of South Africa, practising as such as a director at Honey Incorporated Attorneys ("Honey") of Northridge Mall, Kenneth Kaunda Road, Bloemfontein.

- 2. The contents of this affidavit fall within my personal knowledge, save where otherwise stated or apparent from the context, and are to the best of my belief both true and correct.
- 3. Honey are the attorneys of record of the applicants, and I am the attorney at Honey dealing with this matter on behalf of the applicants.
- I depose to this affidavit for purposes of seeking relief from the Honourable
 Court on an urgent basis against the facts set out below.
- 5. The purpose of this application is to seek the urgent relief contained in the notice of motion. Previously similar relief was sought under case number 9742/2021 ("Case 9742/2021"). When the application papers were issued in Case 742/2021, the applicants formed the view on the advice given to them, that there was no need for that application to be launched on an urgent basis as it was considered that the third applicant would desist from continuing with her defamation of the applicants.
- 6. However, as will appear from that which follows below, circumstances have necessitated the launching of this urgent application for purposes of seeking the relief in the notice of motion, albeit the same as in Case 9742/2021 on an urgent basis.
- 7. Save for that which is stated below, the applicants' case against the respondents is contained in the founding papers in Case 9742/2021. I attach same hereto

annexure "FA1". The applicants rely on what is stated in annexure "FA1" and herein for the relief sought in the notice of motion. Accordingly, I request the Court to consider the contents of annexure "FA1" as incorporated herein.

- 8. The deponent to the founding affidavit in Case 9742/2021, Ms Joani Johnson, cannot presently depose to an affidavit as she has tested positive for Covid-19 as appears from annexure "FA2" hereto and is consequently in isolation. However, should it be possible for her to attend a commissioner of oaths prior to the hearing of this matter, a confirmatory and supporting affidavit from her will be made available to the Honourable Court. In the meantime, however, I submit that I am in a position to depose to this affidavit as the facts herein contained fall within my personal knowledge, as aforesaid. In addition, that which I state below accords with my instructions, in particular seeking that the matter be dealt with on an urgent basis.
- 9. The application under Case 9742/2021 was issued out of the above Honourable Court on 9 June 2021. Same was served by way of e-mail on the first and second respondents on 9 June 2021 as appears from annexure "FA3" hereto. Thereafter the application under Case 9742/2021 was served on the third respondent by the Sheriff on 14 June 2021 by the Sheriff. Although my correspondent attorneys have received telephonic confirmation from the sheriff that same has been served, I am still awaiting the sheriff's returns of service. Should they come to hand prior to the hearing of the matter, they will be made available to the above Honourable Court at the hearing of the matter.

- 10. All of the respondents have filed notices of intention to oppose Case 9742/2021.
 In this regard (and albeit the notices of intention to oppose form part of the bundle of documents in Case 9742/2021) I attach same hereto for the Court's convenience as follows: -
 - 10.1. On 18 June 2021 E Rowan Incorporated Attorneys served a notice of intention to oppose purportedly on behalf of all three respondents, as appears from annexure "FA4" hereto. However, the day before that, the first and second respondents, in person, filed a notice of intention to oppose at the Court, but only sent it to all parties by email on 18 June 2021 as appears from annexure "FA5" hereto;
 - 10.2. Because of the aforesaid, I addressed a letter to E Rowan Incorporated Attorneys dated 21 June 2021, a copy of which is attached hereto as annexure "FA6", wherein I requested E Rowan Incorporated Attorneys to advise exactly on whose behalf they were acting. In addition, and due to that which is stated below, I also posed the following in the fourth paragraph of the said letter: -

"Your client, the third respondent, despite the Application being served on her, persists with her defamatory comments on social media. Should your client not refrain from placing these defamatory comments on social media we will have no alternative but to enrol the Application on an urgent basis. Kindly advise your client accordingly and request her to refrain from publishing these

defamatory comments and/or any statements regarding our clients on social media with immediate effect."

- 10.3. I also humbly refer the Honourable Court to annexures "FA7.1" to "FA7.12", being screenshots of the Instagram account of the third respondent wherefrom it is apparent that the third respondent is continuing with her incendiary and defamatory statements of and about the first and second applicants on social media. I refrain from repeating the entire contents thereof. Suffice it to state the following: -
 - 10.3.1. In annexure "FA7.1" she posted on 21 June 2021 that: -

"Mrs SA is a disgrace"

10.3.2. In annexure "FA7.2" she posted on 21 June 2021 that: -

"I find it ironic that testimonials are done by women that is now again being used by the organization's wrongdoing...

Covering it up wont work this time..."

10.3.3. In annexure "FA7.3" she posted on 21 June 2021 that: -

"I wont stop exposing women abuse Mrs South Africa!!!!!

You are abusing women for your own pockets."

10.3.4. In annexure "FA7.4" (posted 20 June 2021) she appears to have



found support from an unknown source. I humbly submit that given that a trial is envisaged, should the Honourable Court grant interim relief as opposed to final relief, all of these incendiary remarks can be dealt with at the trial;

- 10.3.5. In annexures "FA7.5" (posted 20 June 2021) communication in the same vein occurred on 11 June 2021;
- 10.3.6. In annexure "FA7.6" (posted 20 June 2021) the third respondent stated: -

"I will make it priority to close it down",

thereby leaving no doubt as to her ultimate aim, i.e. to destroy the business of the first applicant;

10.3.7. In annexure "FA7.7" (posted 20 June 2021) a person, apparently supporting the egregious cause of the third respondent, made a defamatory statement as follows: -

"Hi Chandre, no, I read your article on your experience with the Mrs SA pagent (sic) and support you so I wanted to reach out. I feel that this should come out. I have experience with a lady that once entered and because her hubby has an endless pit of money she won which I think is absolute bullshit. So keep going." 10.3.8. On annexure "FA7.8" (posted 16 June 2021) an unknown person joined the conversation as follows: -

"Ek sien jy follow reeds... Wat Joani ook afgepers het met prokureers (sic) om stil te bly. Toe sê ... sy sal nie staan vir Joani agter skerms by judging en waarvoor die organisasie staan nie toe gee sy haar kroon terug en sy kry tot vandag toe gee erkenning dat sy ooit gewen het nie.

My storie het ek geen feite nie behalwe wat ... vir my gesê het en die feit dat Joani geweier het om vir my die finale SMS results of judging forms wou gee nie ongeag hoe sy altyd preek hoe transparent hulle is."

It is thus apparent that even the conjecture of third parties is now making it onto social media;

- 10.3.9. In annexure "FA7.9" (posted 21 June 2021) the letter which I addressed to E Rowan Incorporated Attorneys (annexure "FA6") was posted on the Instagram account of the third respondent with the inscription "No Mrs SA I will not be silenced";
- 10.3.10. In annexure "FA7.10" (posted 20 June 2021) the notice of intention to oppose by E Rowan Incorporated was posted on the third respondent's Instagram account with the subscript "What a wonderful opportunity to present the truth";

10.3.11. In annexure "FA7.11" (posted 21 June 2021) she posted "Mrs \$\times A

is a disgrace", as well as a link which leads one, when clicked on, to an article by Ms Olwethu Leshabane, apparently a contestant during the 2017 competition and in which Ms Leshabane expresses her disappointment for not having won the competition. In this way the third respondent makes the complaints of other non-winners in the competition part of the dispute between her and the applicants. This is, with respect, no less than an attempt to bolster her egregious and defamatory statements:

10.3.12. In annexure "FA7.12" (posted 21 June 2021) she, quite clearly referring to the statement in the founding affidavit, stated that: -


"But lemme guess she will also be labelled as a disgruntled finalist right @Chandre LadyG."

- 11. It is with respect apparent from the above that the third respondent has no intention of ceasing with her defamatory remarks of and about the first and second applicants, despite knowing that a court application to obtain interdictory relief is pending.
- 12. I submit that the behaviour of the third respondent is indicative of *mala fides* on the side of the third respondent and that the statement on annexure "FA7.9" that "No Mrs SA I will not be silenced" constitutes scandalising of the Court as a species of contempt. Furthermore, I submit that the commentary of the third

respondent goes well beyond what is allowed as freedom of speech. At the hearing of the matter argument in this regard will be presented to the Honourable Court.

- 13. I submit that the insistence of the third respondent to continue with her defamatory remarks and her apparent contempt for the Court in that she, in her own words, "will not be silenced" constitutes grounds for this matter to be dealt with as an urgent application. I submit that it is apparent from the conduct of the third respondent that she will not stop making defamatory statements of and about the applicants until such time as there is a court order.
- 14. Accordingly, whereas the applicants initially considered that it was sufficient for the matter to be placed on the normal motion court roll the situation at present requires urgent Court intervention.
- 15. I am advised by my Cape Town correspondent that in cases where the papers have been completed, a hearing date is likely to be allocated for late October or early November 2021. However, in Case 9742/2021 papers still have to be finalised which will likely add 5 weeks to the process. On that basis, a hearing date of somewhere in December 2021 or even 2022 is likely.
- 16. In the meantime, the continuous defaming of the first and second applicants will likely continue and will, no doubt, lead to substantial prejudice, damages and injustice to them and may even lead to the failure of the first applicant.

- 17. I submit that given the above and that which is set out in the founding affidavit in Case 9742/2021 (annexure "FA1"), the applicants will not obtain substantial redress in due course if the interdictory relief, alternatively at least the interim interdictory relief sought in the notice of motion is not granted at urgently. A damages claim in due course will also prove cold comfort if the first applicant is to fail as a result of the continuous defamation of the third respondent. Furthermore, the Court should not allow the third respondent's incendiary and defamatory statements of the applicants to continue and, so I submit, assist the applicants to protect their good names and reputations.
- 18. In regard to the first and second respondents, and although the applicants are not aware that any one of them have made further defamatory publications and/or comments since service of the papers in Case 9742/2021, it is by the very nature of the interwoven facts necessary that the whole application be dealt with as an urgent application. I submit that there is no other practical way for the applicants to obtain the relief and that the first and second respondents stand to suffer no prejudice should the Court hear application also as against them.
- 19. I therefore submit that a case for urgency has been made out so that the Court can at the very least issue an interim order as prayed for in the notice of motion initially issued.
- 20. Accordingly, I pray for an order as per the notice of motion to which this affidavit is attached.
